Entries must include jump height for classes requiring jumps

"According to Chapter 1, Section 27 of AKC Regulations, entries will be limited. Each judge will be limited to a total of 8 hours of judging time per day." Obedience Trials will be limited as follows: Friday limited to 5 hours, Sunday limited to 6 hours. Rally Trials will be limited as follows: Friday limited to 50 entries, Sunday limited to 40 entries. When obedience and rally entries are limited, AKC requires that UDX, Preferred UDX, and RAE classes are listed in the premium. Once the trial's limit has been reached in either Open B or Utility B class, the UDX class will be considered closed and no additional entries for this class will be accepted. Once the trial's limit has been reached in either Preferred Open or Preferred Utility class, the Preferred UDX class will be considered closed and no additional entries for this class will be accepted. Once the trial's limit has been reached in either Rally Advanced B or Rally Excellent B the RAE class will be considered closed and no additional entries for this class will be accepted.

Dogs and ALL equipment must be removed from the show site immediately following Best in Show Judging of the Three Rivers Kennel Club of Missouri show on Sunday, September 18, 2022. Ringside crating available in the Great Hall for Obedience and Rally during those events.

### **MATS MUST BE UNDER CRATES!**

The Show site is available to exhibitors for Three Rivers KC events from 3 PM to 6 PM Thursday, September 15, 2022 and after 6 AM on Friday, September 16, 2022. Set up for Three Rivers reserved grooming & free grooming in the Gateway Hall is available Thursday, September 15, 2022 from 3 PM to 6 PM. Set up for Three Rivers reserved grooming in the Great Hall will be available Thursday, September 15, 2022 following the completion of the National Specialties. Dogs and all equipment must be removed from the show site immediately following Best in Show Judging of the Three Rivers Kennel Club of Missouri show on Sunday, September 18, 2022.

A security guard will be in the building overnight on Thursday, Sep 15, Friday, Sep 16 and Sat, Sep 17, so dogs may be left in the Purina Event Center overnight on those evenings. In accordance with AKC policy, each dog that is left in in the facility overnight must be identified with a tag stating the owner/agent name and where they can be reached in case of an emergency. In the event of multiple entries, one tag will be sufficient provided it clearly outlines the number of dogs & the area in which they are crated. A tag will be available at the Superintendent's desk.

### **RV PARKING GUIDELINES**

There are seventy-four RV parking spaces behind the Purina Event Center. The fee for parking is **\$40.00** per night for full service lot; **\$25.00** for lower lot. Reservations will be made ONLINE (see RV parking information). Overflow parking will be located on the gravel lots above the Main Show Field. All RVs will be REQUIRED to show permit to park. Anyone not displaying required permit will be removed from the show site. THERE WILL BE NO RV PARKING OUTSIDE OF ANY DESIGNATED RV LOT. THREE RIVERS KENNEL CLUB WILL BE IN CHARGE OF ALL PARKING FOR THIS EVENT. RV reservations will be accepted until the lots are full. Refunds will not be made after entries close on September 1st.

### **PARKING**

Exhibitor and visitor parking will be located on blacktop parking lots in front of the Purina Event Center. Vehicles are limited to one parking space. No Ex-Pens or Crates allowed on blacktop, but are allowed on grass areas. Ex-Pens are NOT allowed between the building and the road. No cones allowed in parking areas. No parking in roadways, next to building or on Grass. The THREE RIVERS KENNEL CLUB OF MISSOURI PARKING COMMITTEE will be in charge of all parking for this event.

### **CRATING & GROOMING**

**NO FREE GROOMING SPACES.** Grooming and crating in designated areas only. Reserved Grooming in the Purina Event Center will be 5x10 feet sites with electric on each site. The fee for reserved grooming area is \$25.00 for the entire event. Reservations may be made to the Three Rivers Kennel Club of Missouri (see grooming area application). No dogs allowed in bathrooms. **Dogs may be left in the building overnight Thursday, Sep 16, Friday, Sep 17 and Sat, Sep 18. There will be a Security Guard. The Building will be locked at 10 pm and opened at 6 am. NO CRATES MAY BE PLACED DIRECTLY ON THE FLOORING SURFACE IN THE GREAT HALL. THERE MUST BE PLASTIC OR A RUG UNDER THE CRATE. ALL GROOMING TABLES MUST HAVE RUBBER OF PLASTIC CAPS ON THE END OF THE LEGS OF THE TABLE.** No cones are allowed inside building. NO Ex-Pens allowed inside building at any time. **NO SOFT-SIDED CRATES ALLOWED.** Please stack your crates and limit number of tables. All vehicles must leave their headlights on while unloading. **All exhibitors must abide by the 15-minute unloading/loading parking time limit designated around the Purina Event Center.** NO VEHICLES MAY BE PARKED NEXT TO BUILDING OR IN ANY ROADWAY. VIOLATORS WILL BE TOWED AT OWNER'S EXPENSE.

### **EXHIBITORS & GUESTS**

**No one is permitted anywhere that is marked "Employees Only" and/or "No Admittance."** These are separate divisions of Purina and are not part of the show grounds. Thank you for your interest in reserving an RV space at Purina Farms.

- Check-in time is 3p.m. on the arrival date shown on your reservation confirmation

Purina Farms offers 2 different RV lots on property. The Full-Service Purina Event Center RV lot offers water and sewer as well as 30 and 50amp electric\*. The Electric only Main Show Field RV lot offers 30 and 50amp electric.

Quiet time in the RV area is from 11:00PM to 6:00AM. Any RVs arriving between these hours will be placed in a holding lot until after 6:00AM when they can then move to their designated spots or after 3:00PM depending on the designated arrival date on the reservation.

Day camping is available in 3 different designated lots on property. Spaces are limited and are available on a first-come; first-served basis while there is still availability. Day campers must vacate the lots by 11p.m. on the same day of arrival. Day campers do not need a reservation, but they must abide by all guidelines and be entered/participating in an event on property.

## Overnight Camper Information

Thank you for requesting an overnight camping space in one of the Purina Farms designated RV lots. Our RV Engagement Specialist will respond back to your reservation request within 5-7 business days to let you know whether your reservation is confirmed. Reservations are taken on a first-come; first-served basis and are assigned based on length of equipment (rig) and space availability. If confirmed, you will receive an emailed confirmation that must be shown upon arriving at the front security gate at Purina Farms. You will also receive instructions on how to pay for your space. Full payment by credit card must be received before the space can be confirmed and finalized. Credit cards only.

Check-in time is 3p.m. on the arrival date shown on your reservation confirmation and check out time is 6p.m. on the departure date shown on your reservation confirmation.

Any RVs bigger than 50' must reserve a spot in the full-service Purina Event Center lot. Max size of RV on property is 55'. Tow vehicles are not factored into the length of the spaces as they must be unhooked.

**Spaces are refundable if cancelled more than 3 days out from the arrival date listed on the reservation confirmation. Otherwise, no refunds will be given. Spaces are non-transferable.**

Please note that RV reservations are only accepted for those entered (or those who have dogs/cats entered) in an event that has contracted space which includes the overnight camping lots. Upon request, participants must be prepared to show proof of event entry upon arrival at Purina Farms.

The Purina Farms RV lots are only open to vehicles specifically designed with overnight sleeping accommodations including motorhomes, fifth wheels and travel trailers.

A Recording Fee of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for each recordable single entry class at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). A \$3.50 AKC Recording Fee will be required for the first entry in Rally and \$3.00 for each additional entry in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 5). A \$2.00 Event Service Fee will be required for each entry in 4-6 Month Beginner Puppy. \$2.00 Event Service Fee will be required for each entry in FSS Open Shows. These Fees are paid to the American Kennel Club.

**RETURNED CHECKS / INVALID CREDIT CARDS** do not constitute a valid entry. The Superintendent will add a collection fee of \$25 to the amount of each returned check and credit card. Subsequent returned checks and credit card from the same exhibitors may result in their being put on a cash-only basis. Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge, or barred from competition by action of the Show Committee.

**No Entry** shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.
